* Entitled members may use the dinghy park as follows: junior, student, ordinary and honorary members may store one dinghy in the dinghy park provided it is clearly and indelibly labelled with your name and contact telephone number. Family members may store 2 dinghies under the same conditions. There may be flexibility to store more boats if space permits but this cannot be guaranteed. Members of the Mooring Association may store one tender in the dinghy park during the period between crane-in and crane-out. Applications to store additional boats may be made in writing to the Committee and permission, if granted, may be rescinded at the Committee's discretion. Members of the Mooring Association may store their boats ashore between crane-out and crane-in provided space is available. Cradles and trailers must be removed from the club premises following crane-in.

5. Insurance Indemnity Certificate: please note that this should be signed in **All Cases** – not just for current boat owners.
