## Treasurer's report

1.Membership:- membership subscriptions are being paid promptly by PayPal and cheque. DD subs will be collected during the first week in March and confirmation of those should be available from the accountants shortly thereafter.

2.Burns Supper: There had been some concern about numbers prior to this event but the financial out-turn seems to have been satisfactory with £320 taken to bank from the cash box. (this did include some historic funds and makes no allowance for the modest costs of food.

3. Moorings: I expect the HM to give a full report on the moorings but two matters are of importance regarding finance.

a) Leases: due to be renewed this year and under discussion with Joe Duncan regarding wording and plans for this

b) Maintenance: a temporary dive team may be able to do the work at an acceptable cost in the region of £1000 but with considerable help from members to drive boats. Should this fail then commercial companies will cost in the region of £10,000 or approximately £250 per mooring. While this is still cheap compared to elsewhere, the sudden increase in cost might make some members reconsider mooring and/or membership. Work required this year includes replacement of risers for most of the mid and outers. While funds are available for the tackle in

the moorings reserve, it has been agreed to only refurbish those moorings likely to be in use.

4.Overall, finances remain healthy for the impending season notwithstanding the above matters. The current bank balance is at roughly £48,000 with £3,3000 DD subscriptions still due.
