Fire in the Clubhouse	All Clubhouse users	1	5	5	The entire Clubhouse is a no smoking area. There are smoke detectors in the Clubroom linked to the fire alarm system. No fuel is stored in the Clubhouse. Flares are stored in drybags in the Side store. Electrical appliances are unplugged when not in use. The electrical system has been overhauled (2008) and is inspected by a qualified electrician every 3 years with plug-in electrical equipment tested annually (inspections to be arranged by the Building Custodian). First Aid Fire Appliances (FAFA) are provided in the Galley and by all exits. There is a dedicated fire exit from the Clubroom. There is a manually activated fire alarm and evacuation lights at all exits. The fire alarm system, evacuation lights,	1	5	5
