JW reported that the agreed donation (£200) to the Sea Scouts in thanks for use of their facilities for RIB maintenance had not yet been paid. To accommodate a seat work would need to be done to one of the rowing skiffs and this would be best done now while the boats are not in use. 7	Impact of covid- 19	RJ reported that the COVID focus group had produced a document outlining the Club activities which may be possible under the Scottish Government (SG) "Phases". This had been circulated to the Committee. The Committee agreed that this would form the basis of decisions on activity as the SG and RYAS announced developments. The document would be made available on the Club website and would be highlighted in COVID communications to the membership. The Committee thanked the group for their work on this. CL asked what, if any, provision could be made for Club members to use a RIB to cover dinghy sailing as an informal activity. After consideration of pros and cons it was decided that a small group would look at the possibilities and would bring a recommendation back to the Committee – RJ, CL and CP volunteered. Potential risks to the Club resulting from the current circumstances were identified as loss of members and loss of income from subscriptions, training and catering. CL suggested a refund of subs in view of the lack of sailing activity this year – it was pointed out (see Item 4) that the Club still has ongoing expenses and reduced income so this would not be appropriate. ## Item 4 -Treasurer's Report June 2020

Membership: membership income is at just over £9997 overall subscription income for last year of £10898.

Bank accounts: The new bank account is now being used successfully for most activity with council, insurance and Ofcom DDs all coming from that account. I am still waiting to see if we have successfully transferred the electricity account. There has been one payment to the old account on 1<sup>st</sup> June by Bruce Greig for use of slipway.

Refuse: I have reduced the refuse collection to monthly with a reduction in cost to £10.77.

Fuel duty: £321.62 has been refunded for fuel duty from last season.

Grants: I applied for the government Covid grant and we were awarded the grant in full of £10,000.

Expected expenditure: I await invoices for the fire inspection, railing replacement and gutter clearance. Other than possible moorings work no other exceptional expenditure is identified at this stage.
