There will be a water taxi service available on both dates and the usual bacon rolls will be provided.

Club Duties

Adrian Hodges is managing the duty rosters this season. He is currently filling, with volunteers and by allocation, all slots until the end of May. The roster is also now open for members to volunteer for duties in June and July; at the beginning of April Adrian will roster members to fill any June and July duties for which there have been no volunteers. The duty roster for August onwards will be opened up for volunteers in June. Volunteers for 'race and safety officer' duties need to be at least 18 years of age.

Anyone with a duty (volunteered or rostered) will receive an automated reminder from dutyman to their registered e-mail address but all duties can also be seen on the dutyman website. There will be a club working day starting at 10am on 23 March to prepare the club and its environs for the sailing season. One major task will be removing the turf that is growing on edge of the harbour wall next to the car park so please bring shovels and, if possible, a wheelbarrow. We are also looking for volunteers with powerwashers to clear the weed and algae off the slipway before the start of the sailing season (tides make 23 March unsuitable).

Fancy a cruiser but can't afford it?? Read on

If you have ever fancied the idea of having a cruiser, but cannot justify the costs, why not form a group to buy and share a boat? That is what the Wisp group did. There are six of them, and they share all the expenses.

As individuals the cost of ownership, and upkeep, of a boat can be daunting. However share it four, or six, ways and it becomes more affordable. A simple agreement sets out the group's aims. In Wisp's case, the group owns the boat and everyone is liable for maintenance. The boat is not a part of any member's estate, and is not inheritable. If anyone leaves the group, they do not get a refund. That is the gist of it, but so long as the group agrees, you can have whatever you want.

An example might help. A boat costing £1200. One individual = £1200. A group of six = £200 each. So how about it? Let's go cruising!!
